Notification of the Ministry of Public Health

On Businesses Hazardous to Health (No. 2) B.E. 2560 (A.D. 2017)

Whereas it is deemed expedient to amend the Notification of the Ministry of Public Health on Businesses Hazardous to Health, B.E. 2558 (A.D. 2015), in order for its execution to be effective, consistent with, and suitable for the current situation.

By virtue of the provisions of Section 5 and Section 31 of the Public Health Act, B.E. 2535 (A.D. 1992), the Public Health Minister by advice of the Public Health Committee hereby issues this Notification as follows:

- Clause 1. This Notification shall be referred to as "Notification of the Ministry of Public Health on Businesses Hazardous to Health (No. 2), B.E. 2560 (A.D. 2017)".
- Clause 2. This Notification shall come into force on the date immediately following that of its promulgation in the Government Gazette.
- Clause 3. Prescribing that (1) of Item 9. Service Providing Businesses under Clause 3 of the Notification of the Ministry of Public Health on Businesses Hazardous to Health, B.E. 2558 (A.D. 2015) shall be repealed and superseded by the following provision:
- "(1) Health spa treatment, except treatments offered in sanatoriums according to the Sanatoriums Act, or in a health establishment according to the Health Establishment Act".
- Clause 4. Prescribing that (3) of Item 9. Service Providing Businesses under Clause 3 of the Notification of the Ministry of Public Health on Businesses Hazardous to Health, B.E. 2558 (A.D. 2015), shall be repealed and superseded by the following provision:
- "(3) Massage treatment, except massage treatments offered in sanatoriums according to the Sanatoriums Act, or in a health establishment according to the Health Establishment Act".
- Clause 5. Prescribing that (4) of Item 9. Service Providing Businesses under Clause 3 of the Notification of the Ministry of Public Health on Businesses Hazardous to Health, B.E. 2558 (A.D. 2015), shall be repealed and superseded by the following provision:

(Translation)

"(4) Shower room, steaming room, herbal room services, except services offered in sanatoriums according to the Sanatoriums Act, or in a health establishment according to the Health Establishment Act".

Clause 6. Prescribing that (11) of Item 9. Service Providing Businesses under Clause 3 of the Notification of the Ministry of Public Health on Businesses Hazardous to Health, B.E. 2558 (A.D. 2015), shall be repealed and superseded by the following provision:

"(11) Beauty or hair salon, except those businesses that are governed by the Medical Profession Act or the Health Establishment Act".
