

Notification of the Ministry of Public Health

On Sewage Hauling Forms

B.E. 2561 (A.D. 2018)

Whereas it is deemed expedient to determine sewage hauling forms in order for the entities responsible for sewage management to be able to monitor sewage hauling so as to effectively prevent illegal sewage disposal.

By virtue of the provisions of Clause 13 paragraph two of the Ministerial Regulation on Sewage Management Hygiene, B.E. 2561 (A.D. 2018), the Minister of Public Health by advice of the Public Health Committee hereby issues this Notification as follows:

Clause 1. This Notification shall be referred to as “Notification of the Ministry of Public Health on Sewage Hauling Forms, B.E. 2561 (A.D. 2018)”.

Clause 2. This Notification shall come into force after the expiration of one hundred eighty days from the date of its promulgation in the Government Gazette.

Clause 3. In this Notification,

“Sewage hauling” means withdrawing sewage from sewage tanks or a fixed sewage disposal system and hauling it to a central sewage disposal system;

“Sewage hauler” means an agency or a business operator which is responsible for sewage hauling as follows:

- (1) Authorised local government in accordance with Section 18 paragraph one;
- (2) Other local government or government agencies with which the local government has a mutual agreement in accordance with Section 18 paragraph two;
- (3) A person appointed by authorised local government in accordance with Section 18 paragraph three;
- (4) A person who has a license in accordance with Section 19;

“Sewage disposer” means an agency or a business operator which is responsible for sewage disposal as follows:

- (1) Authorised local government in accordance with Section 18 paragraph one;
- (2) Other local government or government agencies with which the local government has a mutual agreement in accordance with Section 18 paragraph two;

(3) A person appointed by authorised local government in accordance with Section 18 paragraph three;

(4) A person who has a license in accordance with Section 19.

Clause 4. In hauling sewage, sewage haulers and disposers shall oversee and monitor sewage hauling and disposal, as the case may be, in order to prevent illegal sewage disposal as follows:

(1) The person hauls sewage from a service receiver shall complete the Record Form of Sewage Hauler 1 annexed hereto with the original document kept by the sewage hauler and its duplicates each kept by the service receiver, sewage disposer and local official;

(2) The sewage disposer shall complete the Record Form of Sewage Disposer 2 annexed hereto with the original document kept by the sewage disposer and its duplicates each kept by the sewage hauler and local official;

(3) It prescribes that sewage haulers and disposers, as the case may be, shall also submit the Monthly Summary of Sewage Hauling or Sewage Disposal 3 annexed hereto to the local official within the fifth day of the following month.

2. One duplicate shall be provided for the service receiver as a proof of service (as for the next service, which shall be offered within not less than one year or four years, as the case may be).
3. One duplicate shall be provided for the sewage disposer as a proof of service (as an attachment to the Record Form of Sewage Disposer).
4. One duplicate shall be provided for the local official.
