## **Ministerial Regulation**

Prescribing of Fees for Issuance of Licenses, Letter of Notification, and Waste Management Service Providers

B.E.2559 (2016)

By virtue of the provisions of section 5 (1) of the Public Health Act B.E.2535 (1992), the Minister of Public Health issues this Ministerial Regulation, as follows.

Clause 1. To repeal the Ministerial Regulation on the prescribing of sewage or waste collection, hauling and disposal fees and other charges B.E.2545 (2002).

Clause 2. Fees for license issuance under section 19, section 33, section 34, section 38, and section 41 paragraph two, that the local government has the power to issue in local regulations according to section 63, shall not exceed the below fees.

- (1) Operation licenses under section 19
   to operate a business for profit or reciprocal benefits
   at the following issuance costs
  - (a) general sewage or waste collection service provision 5,000 baht/copy
  - (b) general sewage or waste disposal service provision 7,500 baht/copy
  - (c) infectious waste collection and hauling service provision

10,000 bath/copy

(d) infectious waste disposal service provision

15,000 baht/copy

(2) Operation licenses to operate a business

hazardous to health for commercial purposes

as prescribed in the local regulations

to be a business required to be under control in

a locality according to section 32 (1)

15,000 baht/copy

(3) License for market place setup under section 34

(a) license to set up a market place in a building or an open space with up to one hundred stalls

5,000 baht/copy

(b) license to set up a market place in a building or an open space with more than one hundred stalls 10,000 baht/copy

(4) License for food selling place or foodstuff storing place setup in a building or an open space of which the area exceeds two hundred square meters and which is not the selling of articles in market place under section 38

  - (a) setting up a stall

Clause 3. Fees for letter of notification issuance under section 48, that the local government has the power to issue in local regulations according to section 63, shall not exceed the below fees.

Letter of notification for the setup of food selling place or foodstuff storing place in a building or an open space of which the area does not exceed two hundred square meters and which is not the selling of articles in market place under section 38

Clause 4. Fees for services provided by the local government or other parties appointed by the local government to operate sewage or waste collection, hauling, or disposal services on its behalf, that the local government has the power to issue in local regulations according to section 20 (4), shall not exceed the below fees.

- (1) Fee per sewage collection and hauling service 500 baht/cubic meter (the amount that does not exceed half of one cubic meter shall be considered half of the unit and the amount that exceeds half of one cubic meter shall be considered 1 cubic meter)
- (2) Fees for general waste collection and hauling services
  - (a) monthly fee for general waste collection and hauling services
    - 1) the daily amount is below 20 liters

65 baht/month

2) should the daily amount is over 20 liters, but does not exceed 500 liters, it shall be

considered at every 20 liters at the rate of 65 baht/unit (the amount that does not exceed 10 liters shall be considered half of the unit and the amount that exceeds 20 liters shall be considered one unit) 3) the daily amount is over 500 liters, but does not exceed one cubic meter 3.250 baht/month 4) should the daily amount is over one cubic meter, it shall be considered at every one cubic meter at the rate of 3,250 baht/unit (the amount that does not exceed half of one cubic meter shall be considered half of the unit and the amount that exceeds one cubic meter shall be considered one unit) (b) fee per general waste collection and hauling service 1) the amount is below 500 liters 125 baht/time 2) the amount is over 500 liters, but does not exceed one cubic meter 245 baht/time 3) should the daily amount is over one cubic meter, it shall be considered at every one cubic meter at the rate of 245 baht/unit (the amount that does not exceed half of one cubic meter shall be considered half of the unit and the amount that exceeds one cubic meter shall be considered one unit) (3) Fees for infectious waste collection and hauling services (a) monthly fee for infectious waste collection and hauling services 1) the daily amount is not over 13 liters or weight is not over 2 kilograms 500 baht/month 2) should the daily amount is over 13 liters or weight is over 2 kilograms, it shall be considered at every 13 liters or every 2

- (b) fee per infectious waste collection and hauling service is collectible in 2 different service types

- (4) Fee per sewage disposal service 600 baht/cubic meter (the amount that does not exceed half of one cubic meter shall be considered half of one cubic meter and the amount that exceeds half of one cubic meter shall be considered one cubic meter)

- (5) Fees for general waste disposal services
  - (a) monthly fee for general waste disposal services
    - 1) the daily amount is below 20 liters

- (c) fees for general waste disposal services extra fee of 2 baht/person/day is applied on traveler accommodation
- (6) Fees for infectious waste disposal services
  - (a) monthly fee for infectious waste disposal services
    - 1) the daily amount is below 13 liters or weight is not over 2 kilograms

- 2) should the daily amount is over 13 liters or
  weight is over 2 kilograms, it shall be considered
  at every 13 liters at the rate of 1,500 baht/unit
  (the amount that does not exceed 6.5 liters
  or 1 kilogram shall be considered half

  or 1 kilogram shall be considered one unit)
- (b) fee per infectious waste disposal service

should the amount is not over 6.5 liters or weight is not over 1 kilogram, it shall be considered at every 6.5 liters or 1 kilogram at the rate of (the amount that does not exceed 3.25 liters or half of 1 kilogram shall be considered half of the unit and the amount that does not exceed 3.25 liters or half of 1 kilogram shall be

considered one unit)

Clause 5. Prescribing that the local provisions that enable the local government to designate fees under section 20 (4) or under section 63, which are still effective on the day before this Ministerial Regulation comes into force, shall continue to be in force insofar as they are not inconsistent with or contrary to the provisions of this Ministerial Regulation until there are local provisions prescribing that the local government shall have power to designate fees under section 20 (4) or under section 63 in the execution of this Ministerial Regulation, as the case may be.

Note:- The reason for the promulgation of this Ministerial Regulation is as follows.

Whereas the prescribing of fees for sewage or waste collection, hauling, and disposal services, and fees for issuance of licenses, letter of notification in accordance with the Public Health Act B.E.2535 (1992), which is prescribed in the Ministerial Regulation on fees for sewage and waste collection, hauling, and disposal services and other charges B.E.2545 (2002) has been in force for a long time, and, at present, the local government is liable for a great amount of expenses in sewage and waste operations resulting in the desire to improve service fees to suit the economic situations and expense liabilities, and whereas section 20 (4) and section 63 of the Act indicates that the local government shall have power to issue local provisions, prescribing fees that do not exceed the rates prescribed in the Ministerial Regulations in accordance with criteria, procedure, and conditions, it is therefore necessary to issue this Ministerial Regulation.
